### \* Can we claim Gift Aid on your donation?

*giftaid it*

By telling Sobell House that we can claim Gift Aid on your donation, you're confirming that you have read the statement below and that you are a UK tax payer.

1. By agreeing for us to Gift Aid your donation you're confirming that you are a UK tax payer and understand that if you pay less Income Tax and/or capital gains than the amount of Gift Aid claimed on all my donations in that tax year it is your responsibility to pay any difference, or to notify us if you no longer wish for us to claim Gift Aid on your donations.
2. You can cancel this declaration at any time by notifying the charity.
3. If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HM Revenue and Customs to adjust your tax code.
4. If in the future your circumstances change and you no longer pay tax on your Income and Capital Gains equal to the tax that the charity reclaims, you can cancel your declaration (see note 1).
5. If you are unsure whether your donations qualify for Gift Aid tax relief, ask the charity or contact your local tax office for leaflet IR113 Gift Aid.
6. Please notify the charity if you change your name and address. We are required to hold your current address in order to claim Gift Aid.

In order to claim Gift Aid, we need your full name and home (not work) address including your postcode. If you have any queries about the Gift Aid Scheme please call us on 01865 857007.
